Introduction

The Applicant Support Program seeks to serve the global public interest by promoting worldwide accessibility to, and competition within, the Internet. It is an initiative developed in conjunction with ICANN's Applicant Guidebook New gTLD Program and is intended to provide financial and non-financial support for anything regarding the new potential New gTLD evaluation process.

Financial assistance is available in the first round of the New gTLD Program – the application window is 12 January 2012 through 12 April 2012. Starting in the first round, qualified organizations may request financial aid in the form of a reduction in evaluation fees, from the standard fee of USD 185,000 to a reduced fee of USD 47,000. Notifications are planned to be made in November 2012, and the amount of fee reduction will be the same in every case where financial assistance is awarded.

To fund this effort, the ICANN Board of Directors has dedicated USD 2,000,000 for this program as seed money. Additional contributions will be sought throughout the year. The number of fee reductions awarded will be governed by available funds. Details about how entities can contribute to the fund will be available soon.

The Applicant Support Program does not relax the existing criteria for the New gTLD Program. All applicants for Financial Assistance will have to complete the New gTLD Application – requiring clear demonstration of technical, operational and financial capabilities. Additionally, in order to receive Financial Assistance, applicants will be measured against additional criteria and asked to demonstrate: (1) service in the public interest; (2) financial need; and (3) minimum, certain financial capabilities.

Since April 2010, the entire ICANN community has dedicated many hours to the development of this program. The Joint Applicant Support Working Group deserves special acknowledgement for the work of its members from around the world, who developed the New gTLD webpage Final Report, and that is the foundation for the Applicant Support Program. It was formed following a Applicant Support Program Resolution from the ICANN Board of Directors in Nairobi on March 2010 that asked ICANN's stakeholder community "...to develop a sustainable approach to providing support to applicants requiring assistance in applying for and operating new gTLDs."

IMPORTANT NOTE: The decision to apply for Financial Assistance should be made with care. If an application for Financial Assistance does not meet the threshold criteria, that application will be excluded from the entire New gTLD program, not just the Financial Assistance component. Applicants should be aware of this risk.

Why is ICANN offering reduced application fees for certain applications?

The Internet is a global resource, ~~and the~~. The diversity, competition and innovation made possible by the New gTLD Program should provide an inclusive opportunity for all to participate. The Applicant Support Program, ~~conceptualized by ICANN volunteers through the Joint Applicant Support Working Group~~, seeks to serve the global public interest by ensuring worldwide accessibility to, and competition within, the ~~New gTLD Program~~ Domain Name System. This program offers qualified candidates the opportunity to pay a reduced evaluation fee of USD 47,000 instead of the full evaluation fee of USD 185,000.

Critical Dates to Know

- 12 January 2012 - The Application ~~Window~~ submission period for the New gTLD Program and Financial Assistance Applications opens.
- 29 March 2012 – Last day to register in the TLD Application System (TAS). If you do not register by this date you will not be able to apply for a New gTLD or Financial Assistance.
- 12 April 2012 – The Application Window for the New gTLD Program closes. By this date, candidates for financial assistance must submit completed New gTLD Applications AND completed Financial Assistance Applications.
- 30 November 2012 – ~~Final~~ Planned final date for Award ~~announcement~~ notification. At this point candidates will have received one of three possible notifications:



- 1) Qualified (i.e., meets the threshold criteria) and fee reduction awarded.
- 2) Qualified but fee reduction not awarded. In this case, ~~ICANN will send a staggered fee schedule to the applicant.~~ candidate may choose to pay the remaining USD 138,000 evaluation fee or withdraw their application for a refund of USD 42,000.
- 3) Disqualified (i.e., does not meet the threshold criteria) and, as a result, the financial assistance ~~AND the New gTLD application~~ Program Application is rejected.

Note, if disposition on a ~~financial assistance application~~ Financial Assistance Application is made prior to 30 November, ICANN might, at its discretion, make the notification before that date.

30 December 2012 – Last day for candidates who have “Qualified but no award” to either a) make ~~first~~ the third payment in the staggered fee schedule on remaining USD 138,000 and proceed to initial evaluation or b) withdraw their application and receive a USD 42,000 refund.

Candidate Eligibility & Criteria

The Applicant Support Program is designed to provide financial support to ~~deserving~~ qualified (as defined by the criteria below) candidates.

These criteria are independent of detailed criteria in the New gTLD Applicant Guidebook to evaluate candidates to determine their capabilities to operate a registry. The New gTLD Applicant Guidebook criteria must be met in order to be delegated as a gTLD.

The Applicant Support Program does not alter existing criteria for a new gTLD, rather it measures interested Applicant Support candidates against separate criteria to identify those who demonstrate: (1) service in the public interest; (2) financial need; and (3) minimum financial capabilities. Applicant Support candidates rank highest as measured against these criteria will be awarded ~~a~~ the significant reduction in their application fees.

Only one support application for any entity or affiliate of that entity will be considered. The entity may apply for multiple TLDs, but is allowed only one ~~financial support application~~ Financial Support Application.

Candidates who meet these initial eligibility criteria and pay the USD 47,000 ~~application~~ evaluation fee then begin the Initial Evaluation phase in the main ~~gTLD Applications process~~ New gTLD Application Process. Refer to the New gTLD Applicant Guidebook for the new gTLD evaluation process.

Exclusions / Eligibility

Entities requesting support through the Application Support Program first will undergo a review to determine eligibility for the Applicant Support Program. A New gTLD Candidate will be excluded from Financial Support consideration if it ~~is~~:

- ~~Is~~ applying for a gTLD string that is intended to reference a trademark. ~~(However, applications for names of communities or trademarked brand non-governmental agencies are not necessarily disqualified from receiving support if they have obtained legal trademark protection.)~~
- ~~Is~~ a national or federal governmental entity or an entity with controlling interest by a national or federal government.
- ~~Is~~ applying for a gTLD string that is a geographic name as described in the [New gTLD Applicant Guidebook](#).

Those that meet the eligibility criteria immediately above will then be evaluated against specific criteria. ~~Based on the recommendation of the independent, volunteer Joint Applicant Support Working Group, candidates~~Candidates will be evaluated against three criteria sets:

- **Public Interest Benefit** (to prioritize funds for those projects that would offer demonstrable benefit to the public or suitable community group, ~~including support for distinct cultural, linguistic or ethnic communities, as well as communities with a defined social need~~).
- **Financial Need** (to distribute funds to those entities that lack sufficient financial resources to pay for application fees or otherwise execute their projects, or who would not be able to raise those resources through other means).
- **Financial Capabilities** (to help ensure those receiving funding will be able to manage those funds and execute ~~projects~~this project if successful).

The sequence of criteria reflects the order in which the panel shall assess them, because the first test is core to the goal of the New gTLD Applicant Support Program.

Evaluation Fees & Process

Eligible candidates will be required to pay the fee in two phases: the standard non-refundable USD 5,000 registration fee upon registration in the TLD Application System (TAS); and a subsequent USD 42,000 ~~application fee~~ evaluation fee deposit at the time of application submission. For specifics about matters of payment, please reference the New gTLD Applicant Guidebook.

Fee Schedule and Refunds

- Applicants that are “Qualified and awarded a fee reduction” will have the remainder of the USD 185,000 fee waived. No other fees and costs associated with the New gTLD Program will be affected ~~one way or another in this program.~~

Fee Refunds

- ~~Candidates~~ Applications that are “Qualified but ~~no award~~ not awarded a fee reduction” may choose to pay the remaining USD 138,000 evaluation fee or withdraw their application for a refund of USD 42,000. This decision must be made within 30 days of the award announcement. ~~ICANN will provide a timetable for staggered payments. The candidate who chooses to these applicants. If payment deadlines are missed, continue with evaluation can make payments according to the staggered fee schedule below.~~

Notes: (1) After the third payment of USD 73,000 and prior to the Initial Evaluation posting, if the applicant chooses to withdraw, USD 65,000 will be furnished a refund.

- Important: Candidates not meeting the minimum threshold criteria will not proceed further in the program and refunded.
- (2) If payment deadlines are missed, previous payments will not be eligible for a

refund. This means that the candidate-refunded and the applicant is subject to disqualification.

- Candidates that are "Disqualified," i.e. do not meet the threshold criteria described below, will be excluded from the New gTLD Program. If the application is disqualified in both 1) Reduced evaluation fee AND 2) New gTLD Application, USD 42,000 of the evaluation fee will be refunded unless the SARP reasonably believes there was willful gaming.



The application truly demonstrates financial need, benefits the public interest, and meets the minimum qualifications.



Process

The application process processes for both the New gTLD Program and the Financial Assistance program is lengthy and are comprehensive. Please start as early as possible to ensure that your application is complete in time to be considered.

through by

By checking this box, you agree to certain terms, including rejection of the New gTLD Application if Financial Assistance threshold criteria are not met by your application.

~~Step 4:~~ Complete New gTLD Program Application form AND supplemental Financial Assistance Download the two forms. The supplemental Application Support forms must be downloaded, filled out, and then uploaded to from TAS with supporting documents: (1) Public and (2) Confidential Components for Financial Assistance Application. Both are .doc files.

~~Step 5:~~ Pay USD 42,000 evaluation fee with the submission of your New gTLD AND Financial Assistance applications. In accordance with the requirements of the gTLD Application process, payment must be received by ICANN no later than 12 April 2012. Fill out the two forms, providing all pertinent information to each question. Save as .doc or equivalent files ensuring that all your formatting is retained, and then convert the Word documents to PDF documents. Forms must be filled out in English. (Supporting data may be submitted in other languages.)

~~Step 6:~~ Receive award notification. Announcement puts candidates in three categories Upload the two PDF forms to TAS. Candidate may upload other supporting documents that may be helpful for evaluation. Note that TAS will not accept Word documents and therefore, all documents must be in PDF or formats that are acceptable to TAS.

~~Step 7a:~~ If you are qualified and selected for reduced fee, you will begin the Initial Evaluation of the New gTLD Application process. Refer to the Applicant Guidebook for full details. After completing the Applicant Support request, you will be directed to pay the discounted USD 42,000 evaluation fee. Pay the fee per the instructions in TAS.

~~Step 7b8:~~ Complete and submit your TLD application. In accordance with the requirements of the New gTLD Application Process both the application must be submitted and payment must be received by ICANN no later than 12 April 2012.

~~Step 9:~~ Receive award notification. Candidates will be placed in one of three categories described in Step 10.

~~Step 10a:~~ If you are qualified and selected for reduced fee, you will begin the Initial Evaluation of the New gTLD Application Process. Refer to the New gTLD Applicant Guidebook for full details.



Step 10b: If you are qualified with no award, ~~the Candidate~~you must decide between one of two options within 30 days of the announcement:

- a) Option 1: Self-fund the remaining USD 138,000 according to the staggered fees payment schedule furnished by ICANN, and begin the Initial Evaluation process.
- b) Option 2: Withdraw and receive a refund of USD 42,000.

Step ~~7e~~10c: If you are disqualified, your New gTLD Application will be ineligible for further review. ~~No refunds will be made in this instance~~You will receive a partial refund of USD 42,000 unless the SARP reasonably finds there was willful abuse.

Evaluation

An independent Support Application Review Panel (SARP) will perform the scoring of the three main criteria based on information provided in the Financial Assistance application. The SARP may also rely on the organization's New gTLD Application, public comments, and independent research, if desired. However, the Financial Assistance application should stand ~~on its own~~alone and applicants should not assume the New gTLD Application has been fully read by the SARP. Guidance has been provided where components of the applicant's New gTLD Application might also be applied to Financial Assistance applications.

The criteria are, to a certain extent, subjective. That subjectivity is deemed necessary to enable the SARP to reach a fair result and provide the discretion to interpret the information provided to it in the best light. While efforts have been made to systematize the scoring process, interpretation of the criteria is at the sole discretion of the SARP.

At its discretion, the SARP can ask clarifying questions of candidates. To ensure that all applications are processed in a timely manner, candidates will be given two weeks to respond to clarifying questions.

Notice: SARP panelists will have access to New gTLD Application materials relevant to the SARP evaluation. The SARP's objective is to establish whether applicants meet the Financial Assistance criteria – but not to decide relative merits of New gTLD ~~applications.~~Applications. Therefore, the SARP may arrive at apparently inconsistent conclusions than gTLD Evaluation panels when evaluating similar documentation. This is because the two different evaluation processes have different objectives, criteria and review processes as the basis for ~~its~~their evaluations.

Scoring Methodology

The following are the criteria for the Application Support Program. The criteria are used both as a threshold and to rank qualifying candidates. Once the highest scoring candidates have been identified, the SARP also will work to ensure diversity in its final funding decisions across areas such as language, script, cultures, business models, and regions to ensure that those who receive the fee reduction will tend to most amplify the benefit.

Threshold: As described in the Applicant Support Process document, candidates must meet a threshold score to qualify for financial assistance and keep their ~~new gTLD application~~New gTLD

Application active. If the threshold is not met, the Financial Assistance Application AND the New gTLD Application will be rejected.

Please note that it is not necessary to score the maximum points allowed in order to qualify and it is not necessary to score at least one point in every category. ~~The~~To qualify for Financial Support and meet the threshold, the candidate must meet the minimum score per criteria set, indicated below.

To meet the threshold, support applications must score at least:

- 5 of 9 points on Public Interest Criteria, the first criteria set.
- 3 of 5 points on Financial Need criteria, the second criteria set.
- 1 of 2 points on Financial Capability criteria, the third criteria set.

The threshold is set to discourage abuses ~~as recommended by the ICANN community through its Joint Applicant Support Working Group Report.~~

Rank ordering: As described in the Applicant Support Process, those meeting the threshold will then be rank-ordered using the same criteria. ICANN has established an Applicant Support Fund. Candidates ranked highly enough to receive funding support will receive the USD 138,000 fee reduction. After the initial fund (presently USD 2,000,000) is exhausted, candidates who are not ranked highly enough to receive funding support are eligible for non-financial support, given an opportunity to pay the full application-evaluation fee and proceed into Initial Evaluation, or apply for withdraw the application and receive a full USD 42,000 refund.

~~Criterion~~Criteria and Questions

The development of criteria for evaluating Financial Assistance ~~applications~~Applications is described further in the Applicant Support Criteria document. Questions follow each ~~riterion~~criteria below and are repeated in the Financial Assistance ~~application~~Application. Additional questions might be added if it were determined that additional information would be helpful to the SARP and fulfilling its role.

Public Interest ~~Criterion~~Criteria

Candidates will receive points as indicated below for demonstrating each of the following public interest criteria. ~~Candidates~~ should indicate on their application for funding support which criteria they believe their application meets. Candidates do not need to meet all criteria to meet the threshold or qualify for financial assistance, but priority will be given to those who are scored the highest.

Criteria #1 - Public Interest		Maximum Points
1. Community based project	<p>The ICANN New gTLD Applicant Guidebook specifies that each applicant must declare if its application is a community-based project. Applicants for financial support that also have indicated that a project is community-based will be evaluated by the SARP teams against the four Community Priority evaluation criteria found in Module 4 of the New gTLD Applicant Guidebook: community establishment, nexus between proposed string and community, registration policies, and community endorsement. Rather than following the strict scoring methodology in the New gTLD Applicant Guidebook, the SARP will perform a high-level review to determine whether the applicant generally meets those criteria. Applicants that generally meet the criteria in the four tests will be given 1 point. -Applicants that do not meet this threshold will receive 0 points.</p> <p>It is important to note that while the SARP and the ICANN new gTLD evaluation panels are using similar criteria in certain cases, the SARP's objective is to identify those applicants most worthy of financial support to help reduce barriers to entry for the ICANN application process, not to evaluate an applicant's new gTLD application. Some applicants that receive funding support may not ultimately be successful with their new gTLD applications. Given that the SARP's priority is to identify those candidates that meet public interest priorities and not to address a contention set, the SARP will be given instructions to be more liberal in its interpretation of the Community Based priority criteria. In this regard, SARP findings related to community-based projects may be somewhat inconsistent with the Guidebook described Community Priority Evaluation that the financial aid applicant may later face.</p>	1

Award Decisions

In the case that available funding cannot provide fee reductions to all *bona fide* requests (i.e., requests that meet the threshold scoring requirement), the scoring system enables the SARP to rank and prioritize eligible applications and award financial aid to those determined to best meet the three criteria.- Once the highest scoring candidates have been identified, the SARP also

will ~~work~~ have discretion to ensure diversity in its final funding decisions across areas such as language, script, cultures, business models, and regions to ensure that those who receive the fee reduction will tend to most amplify the benefit.

A relatively high score threshold has been established to ~~identify those who do not meet basic financial need and public interest benefit criteria and in order to help~~ mitigate potential for gaming. Those that do score high enough will receive a fee reduction from USD 185,000 to USD 47,000. Those candidates that meet the established need/public interest threshold, but who do not score highly enough to benefit from ICANN Financial Support will be given an opportunity to pay the remaining ~~application~~ evaluation fee balance of the USD 138,000 and proceed forward in the ~~New~~ new gTLD application program. There are no partial awards. There is no appeal mechanism outside the generally available ICANN mechanisms.

Additional Information

Public Comment Process - Public portions of all applications will be posted approximately on 1 May 2012, including those requesting financial support. Comments about Applicant Support Program candidates that relate to ‘financial need’ or ‘public interest’ will be made available to the SARP.

No Appeals Process – The award decision by the SARP is considered final and there are no processes for appeal. Please ensure your eligibility prior to your submittal of your application.

Reporting - To provide for continual improvement in the program, applicants receiving support will be required to ~~provide a feedback report describing how the significant reduction in fees helped~~ cooperate with ~~the execution~~ economic studies, including studies relating to the effects of their project. ~~fee reductions.~~
