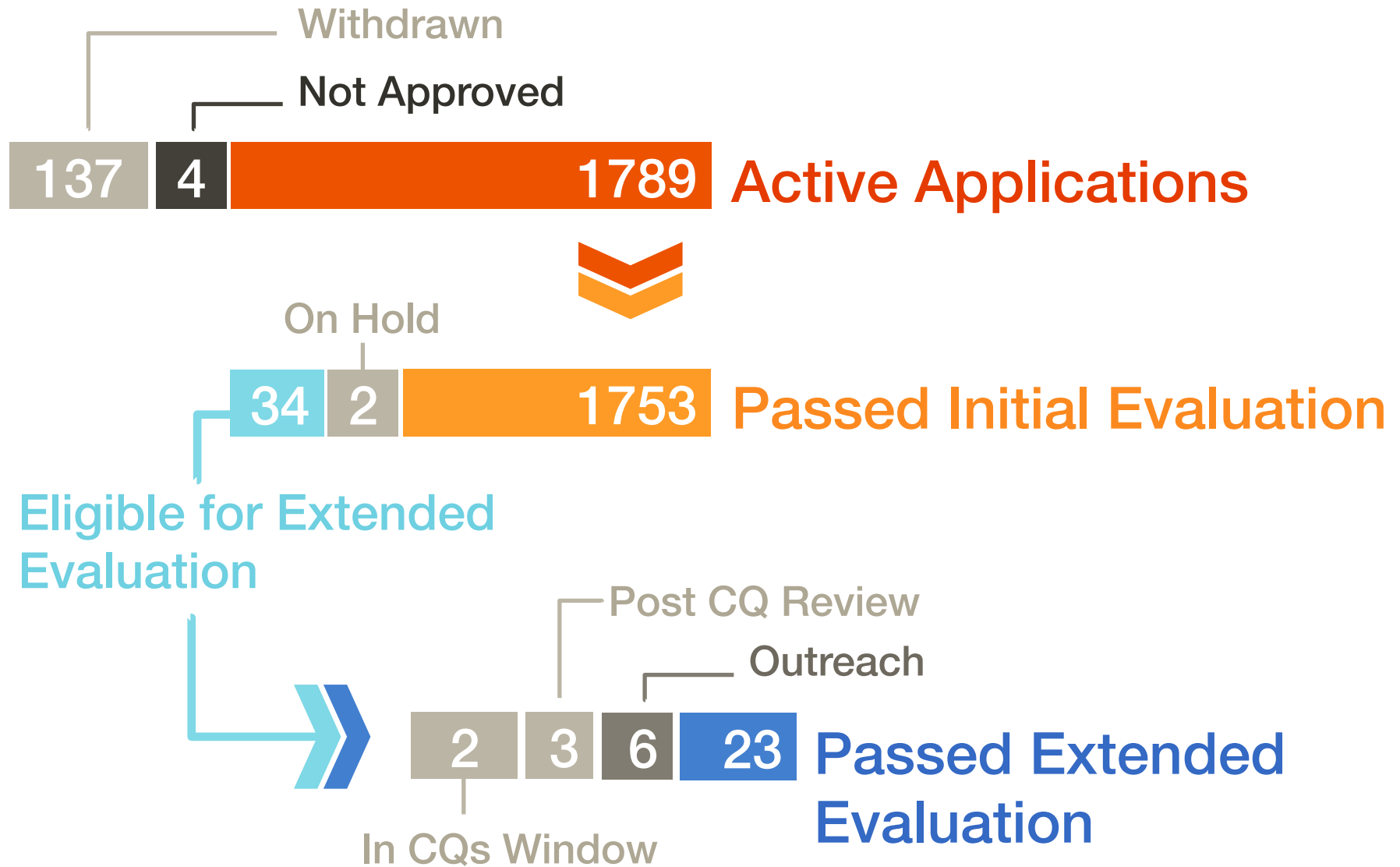

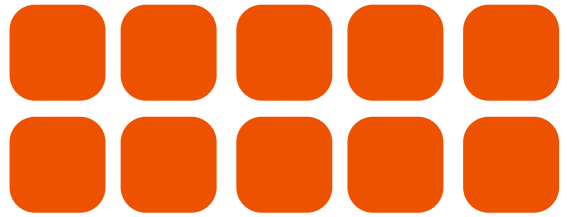

Contracting Implications

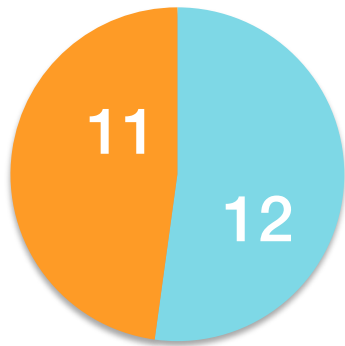
- + Applicants have the option of signing the Registry Agreement in its current form
- + If, and when, Specification 13 is approved, applicants would be afforded, on a nondiscriminatory basis, the opportunity to sign an amendment or modified form of the Registry Agreement

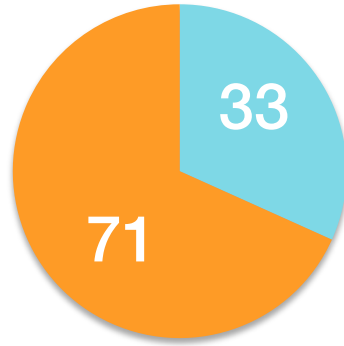
Resolution and Outcome Statistics

+ Over 73% of all objections have been resolved

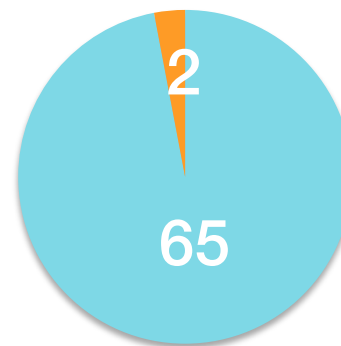

In Progress



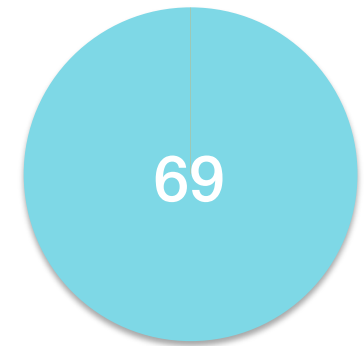
Limited Public Interest

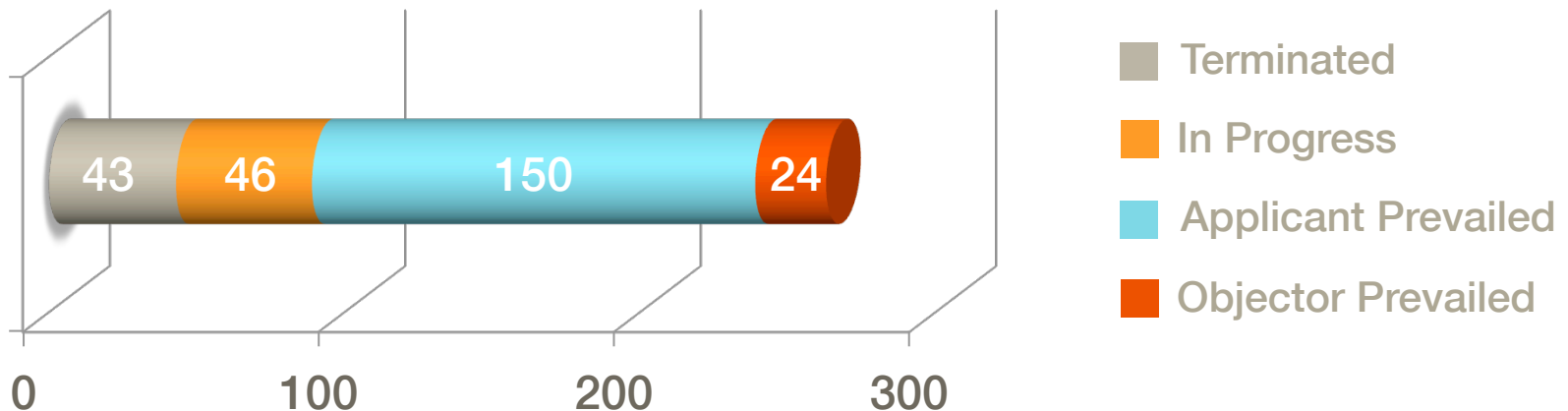

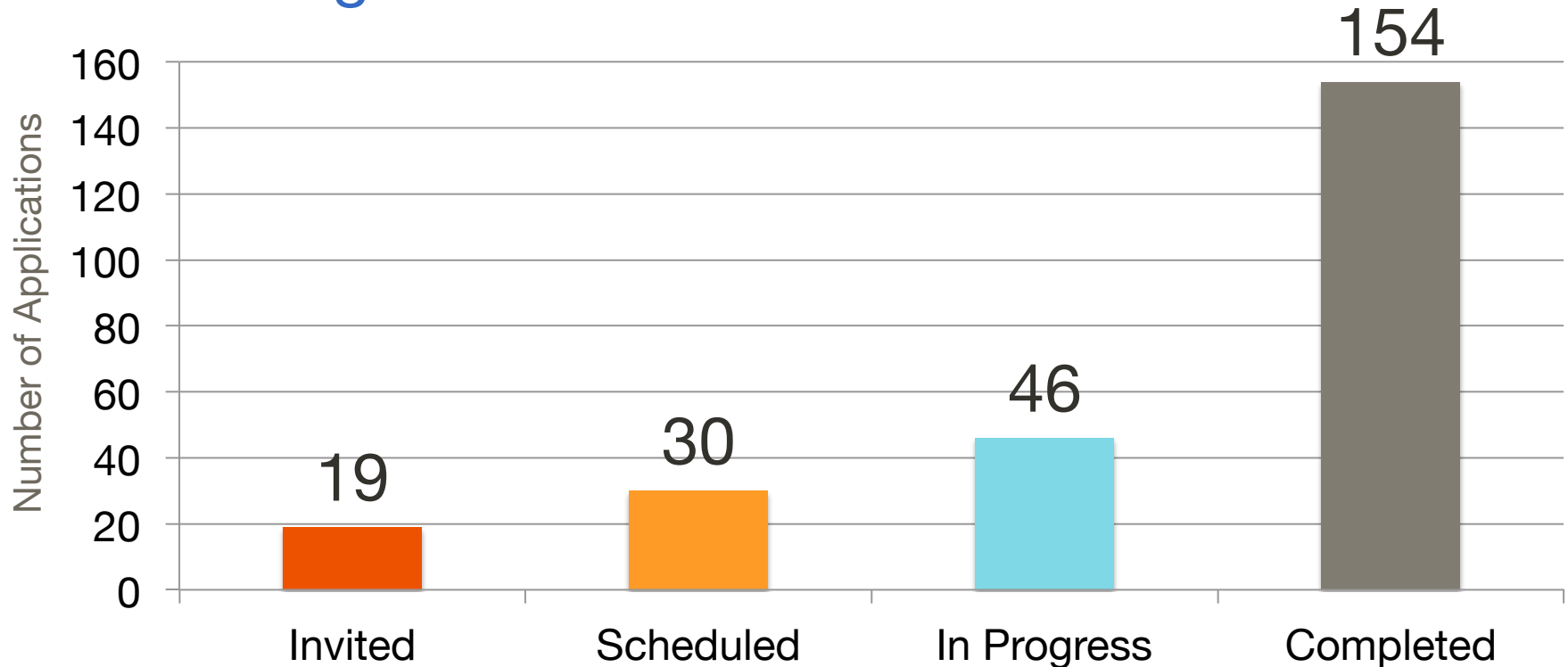

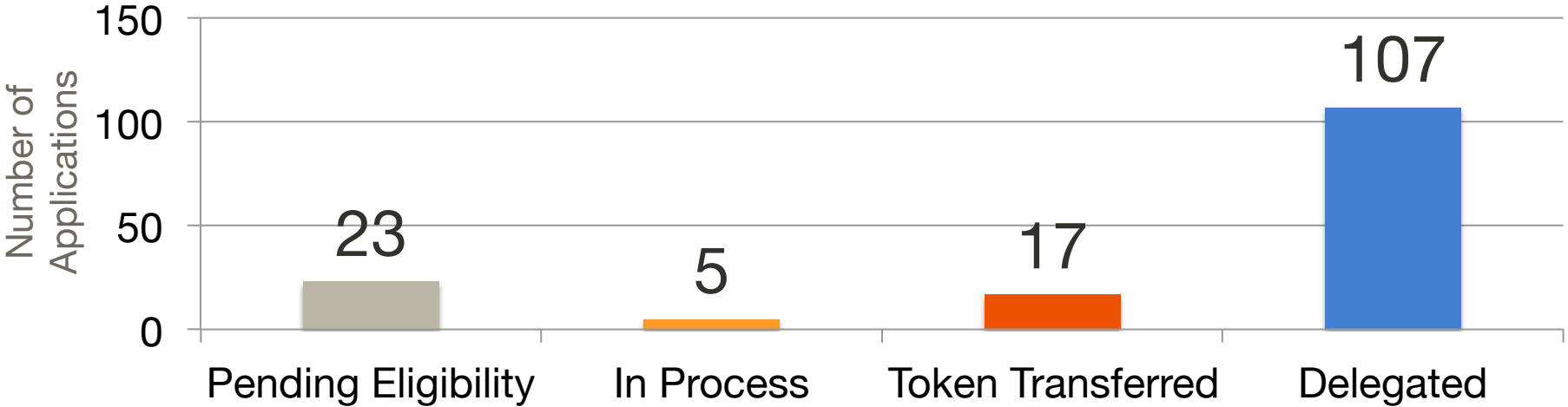

 - Launched outreach campaign to raise awareness and help enterprises react, along with information hub: <http://www.icann.org/namecollision>
- + 3 January 2014
 - Educational materials published in Arabic, Chinese, French, Portuguese, Russian, Spanish
- + Outreach Status
 - 29 news articles published in 10 countries, covering 6 different languages
 - Made contact with 60+ IT industry associations across Africa, Asia Pacific, Europe, Latin America, North America
