

**New gTLD Program**  
**Prioritization Draw Representative or Third Party Proxy Designation and Release**

On 17 December 2012, the Internet Corporation for Assigned Names and Numbers (“ICANN”) will conduct a Prioritization Draw at the Hilton Los Angeles Airport, in Los Angeles, California, USA, to assign a priority number to each gTLD application for processing. By this form, the undersigned applicant (“Applicant”) designates an Applicant Representative (“Representative”) or Third Party proxy (“Proxy”) for purposes of purchasing a ticket for the Prioritization Draw (“Ticket”) for each of the Applicant’s gTLD applications identified below. The Applicant acknowledges that it may designate anyone who is an Officer, Director, Principle or contact listed in the Application as a Representative. The Applicant acknowledges that it may designate the following as a Proxy: (i) a third-party individual who the Applicant has independently identified; or (ii) a third-party individual selected from the “Optional Proxy List” provided by ICANN as a service to Applicants.

The Applicant acknowledges that, in order to purchase a Ticket for each application identified below, the Representative or Proxy must bring: (i) a government-issued photo identification containing the name and address/passport number identical to the information provided in this Designation Form; and (ii) this Form, completed with the Application ID number, applied for string, and the unique Prioritization Draw code (“Code”) that ICANN provided to the Applicant for each application. The Applicant has informed its Representative or Proxy of the foregoing requirements. **IF THE NAME AND ADDRESS/PASSPORT NUMBER DO NOT MATCH THOSE LISTED ON THIS FORM, THE REPRESENTATIVE OR PROXY WILL NOT BE ELIGIBLE TO PURCHASE A TICKET.**

By completing this Designation Form and identifying a Representative or Proxy, the Applicant acknowledges that it is under no obligation to: (i) designate a Representative or Proxy; (ii) designate a Proxy from the Optional Proxy List, if applicable; or (iii) otherwise participate in the Prioritization Draw. By signing this agreement, the Applicant assumes any and all risk associated with using a Representative or Proxy, including any and all risk associated with using a Proxy from the Optional Proxy List, if applicable. The Applicant hereby releases ICANN from any liability for the Representative’s or Proxy’s failure to perform or for the manner in which the Representative or Proxy performs, or for any other reason. The Applicant agrees that it will not make any claim against ICANN for injury arising from the Representative’s or Proxy’s failure to perform or for the manner in which he/she performs or for any other reason related to the use of a Representative or Proxy, including one selected from the Optional Proxy List, if applicable. If the Applicant uses a Proxy from the Optional Proxy List, the Applicant hereby releases the Proxy from any liability for the performance of the Proxy services. The Applicant also agrees that if it uses a Proxy from the Optional Proxy List, the Proxy shall only provide proxy services, and will not provide Applicant with any advice, opinion or counsel; no attorney client relationship will be formed between the Applicant and the Proxy selected from the Optional Proxy List.
